

#### ARCHITECTURAL DESCRIPTION:

The barn at 3 Maple Street was built c.1899 in the Stick Style. This 7x5 bay, wood frame, 2-1/2 story barn sits on a granite foundation. The barn is clad with wood shingles with scalloped shingles on the second story above the belt course. The gable roof is covered with asphalt shingles. A ventilator tops the building at the cross gable. A weathervane is attached to the ventilator. The main entrance contains double barn doors, 10' tall. The windows contain a variety of sash including 2/2 wood sash, and Queen Anne sash. The cornice is enhanced with exposed rafter tails.

## **HISTORICAL NARRATIVE:**

This barn was built in the late 19th century. originally it was part of Horatio Adams' property which fronted on Summer Street. The 1912 and 1925 map indicated that the barn was in "private" ownership. By 1943 the Sanborn map labels this barn as "Cranberry screen & warehouse." Apparently, the barn was owner by Edgar W. Loring. Loring owned a substantial amount of property in Kingston including commercial property on Summer Street and property on "the Nook" which he and his brother, Waldo acquired in the 1920's and opened it for land sales.
