R E P O R T .

IN this, the first Report, we do not expect to arrive at perfection. It will fall short of giving entire satisfaction, and may of meeting the demands of a majority of the people, but by our failings, our successors may approximate nearer what is required.

We have endeavored to perform the various duties left to our care, as though for our individual interest. The sheds have been removed, and a wall erected in their stead; the bridges have been repaired, and the back taxes have been collected. The poor have been cared for, and though we always have them with us, this year we have more than in preceding years, and though some have been removed from our care by death and otherwise, their places have been more than supplied by new recipients. We have aided during the time, twenty-one different persons, and sixteen are now receiving help from the town, nine of which are in our Poor House, two in Brattleboro, Vt., one in Taunton, and the remainder, endeavoring with a little assistance, to live by themselves. Our expenses in this department are less than during the previous year, and we think \$1100 enough for the coming year's expenses.

With the last year's appropriation for highways, our roads may be kept in as good condition as at present. To make them equal to the roads in towns having a clayey soil, and none of our loose sand to deal with, would require a great sum. We advise to raise \$650 for surveyor's purposes, and \$1000 in anticipation of building the new road lately laid out by the County Commissionera, and specified to be built on or before the 10th of July next.

As we are to have a Report of the School Department, let it suffice to say that we think the usual amount of \$2000 as sufficient, and we advise to raise the same.

Based upon our Estate Bill, we assessed a tax which has been collected, with the exception of about \$40, and a part of this was assessed upon individuals who have paid a tax in other towns. By paying taxes at an earlier day than in former times, a part of the difficulties which have always attended the collecting of taxes, has been removed. Many taxes are assessed upon transient citizens, who are here at the first of May, through the summer, and take their departure early in the winter to parts unknown. These taxes are usually Poll taxes. But in case they have families, they are for school books also, in which case they not only avoid paying a tax, but leave a bill for school books for the town to pay. Money

is lost in this way every year. A part of our citizens are dependent upon what they earn from day to day for a livelihood. With this class, the summer is the best time to pay a tax, as they usually have constant employment during the warm season, and receive ready cash as soon as the work is performed. The cash system is fast taking the place of the credit system in most all business transactions, and should in the payment of taxes. A tax is due from the time it is made, and ought so to be considered; not because a few months are allowed for their collection that the town has no demand previous to that day.

We would call your attention to the present method of drawing money from the treasury, requiring that all orders, from whatever department, shall be signed by the Selectmen to give them validity. It is in our opinion an unnecessary arrangement. It does seem right that the employers should draw the orders for those they employ. The Surveyors, School Committee, &c., should draw the orders in their respective departments, being the persons who shall best know what is right. By the present method they do virtually give the order. The Selectmen have no authority to say to the Surveyor or School Committee—"You shall not draw this money;" besides it would be a piece of impertinence to say to either, "We know better than you what your hands deserve." They take their power from a higher source; hence the Selectmen can only write another order, when one from the original party would have been sufficient, which is doubling the amount of writing, to say nothing of the inconvenience to those in favor of whom the orders are drawn, who not unfrequently earn, and dearly too, the amount of the order, seeking the necessary signatures. A Report is required. Grant it. Let each of the Officers report on or before the 1st day of March, a list of orders drawn, instead of a list of bills, for the Selectmen's approval. A Report can be drawn quite as accurate and with much less trouble.

We would also call your attention to our burying ground, one of the oldest in the country. While the inhabitants of other towns are expending large sums to adorn their old burying grounds, and larger sums upon more modern grounds, our old yard is fast becoming a forest of briars and wild cherry trees, and the stones which mark the last resting places of our ancestors, are dilapidated and defaced, and the inscriptions upon them becoming erased by the hand of time.
