To the Residents of Kingston,

This afternoon the Massachusetts Department of Public Health announced that there were 1,677 confirmed positive cases of COVID-19 in Plymouth County. This represents an increase of 170 confirmed cases, from yesterday's count of 1,507. **The Town of Kingston remains at ten confirmed positive cases of COVID-19.** Kingston's Health Agent and Public Safety Officers will continue to monitor these local cases. Due to privacy requirements, the demographics of these cases will remain anonymous.

Kingston's Emergency Management Team met today to discuss the Town's ongoing response to the COVID-19 pandemic. Fire Chief Mark Douglass reported to the group that the current system in place to obtain personal protective equipment (PPE) from the Massachusetts Emergency Management Agency (MEMA) is working quite well. Chief Douglass will continue to send his weekly requests for replenishments of PPE to MEMA, for both the Fire and Police Departments. We anticipate receiving PPE from MEMA early next week, to replace what was used over the last seven days.


With the holiday weekend around the corner and sunshine in the forecast, all members of the Team wanted to reiterate the need for residents to continue to adhere to the Massachusetts Department of Public Health's stay-at-home advisory and social distancing guidelines. We recognize that these advisories are awkward at times, inconvenient at other times, and during holiday weekends like this when we want to be around extended family and friends downright burdensome, but the decisions we make each and every day collectively impact the health of our entire community. Maintaining social distancing, vigilant hand washing, and honoring Governor Baker's stay-at-home advisory helps prevent the spread of the virus, helps preserve hospital capacity for those who are very ill, and preserves the supply of personal protective equipment that is critically needed by our first responders and frontline medical workers. So, please remember as you enter the weekend, by staying apart we are actually coming together to save lives and prevent the transmission of COVID-19.

This morning at 10:30 AM Kingston aired another Live COVID-19 Update on PACTV. Today's program featured Deputy Fire Chief Adam Hatch, State Rep. Kathy LaNatra, and Kingston's Director of Recreation Sue Woodworth. The program will be replayed on Kingston's government channels (Comcast 15 and Verizon 42). We will provide a link to the program on the Town's website once it becomes available.

Parents and residents looking for a fun weekend activity are encouraged to create cards, notes and drawings of inspiration and hope for Kingston's seniors. The Council on Aging is accepting these items from members of the community. They ask that you bundle your letters, cards, and pictures, and leave them unsealed in the designated box outside the front door to the COA. Please include your name, or the name of your group and associated contact information. If you would prefer to donate blank note cards for COA staff to use to send special messages to seniors, those too are welcomed. All donated pieces will be reviewed and disinfected by COA staff before being sent to seniors.

With confirmed cases of COVID-19 on the rise, Kingston's Emergency Management Team and Board of Health would like to remind you that this is a crucial time for infection control. Maintaining social distancing, limiting exposure to others, avoiding crowded places, and vigilant hand washing are vital steps in slowing the spread of this disease.
